

ASI Surpasses 101k index levels with N563bn Gain; Naira Weakens by 1.57% Against US Dollar, Closes at N1,627.40 in Official Market....

The Nigerian Equities market wrapped up the trading week with bullish momentum, marking a full week of positive market activity. The All-Share Index (ASI) surged by 0.99% to settle at 101,330.85 points, with more gainers (29) than decliners (22) on the Exchange. Similarly, the market capitalization of listed equities mirrored this growth, ascending by 0.99% to N57.29 trillion, contributing to a year-to-date return of 35.52% for the benchmark index. Notable positive price movements were observed in MTNN, DANGSUGAR, NASCON, IKEJAHOTEL, and DEAPCAP, which recorded increases of +9.99%, +9.98%, +9.97%, +9.87%, and +8.62%, respectively. Conversely, FTNCOCOA, CILEASING, GUINNESS, GUINEAINS, and ABCTRANS experienced declines of -9.80%, -8.66%, -8.39%, -7.89%, and -7.69%, respectively. Performance across the sub-sector indices varied, with gains of 0.28% and 1.05% in the Banking and Consumer Goods indexes, respectively. However, the Insurance sector declined by 1.58%, while the Oil/Gas and Industrial indexes remained stable. Trading activity on the NGX saw improvement, with total deals and value rising by 11.10% and 12.11% to 10,786 trades and N19.88 billion, although the total traded volume declined by 35.44% to 358.12 million units. At the session's close, TRANSCORP emerged as the most traded security by volume with 92.87 million units transacted in 1,088 deals, while TRANSPOWER led in traded value at N11.65 billion.



Money Market

On Friday, in the money market, NIBOR rates trended higher across all tenor buckets. The Overnight, 1-month, 3-month and 6-month rates advanced by 144bps, 145bps, 121bps, and 129bps, respectively. Key money market rates, including the open repo rate (OPR) and overnight lending rate (OVN), concluded at 29.82% and 31.00%, respectively.

In the Nigerian Interbank Treasury Bills Yield (NITTY) space, rates across all tenor buckets moved upward, with increases of 23bps, 58bps, 89bps, and 56bps for the 1-month, 3-month, 6-month, and 12-month periods. The secondary market for Nigerian Treasury Bills displayed mixed trend, thus the average yield increased marginally by 0.01% to 17.81%.

Bond Market

In the bond market, trading activity was on a cautious thread, as the average yield stayed muted at 18.01%.

In the sovereign Eurobonds market, mild positive sentiment prevailed, causing a marginal 0.01% decrease in the average yield to 9.71%.

Foreign Exchange Market

Turning to the foreign exchange market, the naira weakened against the dollar, depreciating by 1.57% to close at N1,627.40 per dollar in the official market. The parallel market also witnessed a 0.44% weakening, closing at N1,600 per dollar on Friday.

Global Commodity Market

In the global commodity market, oil prices decreased, as Brent crude fell by 0.27% to \$82.74 per barrel, while WTI crude also dropped by 0.51% to \$78.53 per barrel
