

ASI Maintains See-Saw Movement for Fifth Straight Day, Losing N173.15bn; NIBOR Declines Across Tenor Buckets.....

Friday's session marked the fifth consecutive day of bearish market activity on the Nigerian Equities market. The All-Share Index further declined by 31 basis points to close at 99,539.75 points. Similarly, the market capitalization of listed equities moderated by 31 basis points, indicating a total market loss of N173.15 billion, to settle at N56.29 trillion. Sell-offs were observed on UNITYBANK, FBNH, TANTALIZER, DEAPCAP, and CAVERTON, with their respective share prices declining by -10.00%, -9.83%, -8.57%, -7.35%, and -6.83%. The market witnessed more laggards (20) than gainers (14), and across the sectoral front, sentiment was predominantly negative, with three of the five tracked sectors closing in negative territory. Consequently, the Banking, Consumer, and Industrial Goods indexes declined by 2.77%, 0.03%, and 0.01%, respectively, while the Insurance index advanced by 0.38%, and the Oil/Gas sector had a lackluster performance. Trading activity levels also showed a negative trend, with notable decreases in the total number of deals, traded volume, and value for the day, nosediving by 7.22%, 9.81%, and 2.60%, totaling 7,168 trades, 257.86 million units, and N5.39 billion, respectively. UBA emerged as the most traded security in terms of volume, with 38.72 million units changing hands in 687 trades, while GTCO led in traded value at N1.31 billion.





Money Market

In the money market, NIBOR declined across the board for most maturities tracked, suggesting improved liquidity. Notably, the Overnight NIBOR declined by 64bps to settle at 31.83% (from 32.47%). Likewise, Key money market rates such as the open repo rate (OPR) and overnight lending rate (OVN) decreased to conclude at 29.39% and 30.25%, respectively.

In the Nigerian Interbank Treasury Bills market, the Nigerian Interbank Treasury Bills True Yield (NITTY) increased for all maturity gauges. The average secondary market yield for Nigerian Treasury Bills rose by 7.29% to close at 25.04%.

Bond Market

In the secondary market for FGN Bonds, trading activity exhibited a bullish trend, resulting in a decrease in the average yield by 0.22% to 19.04%. This decrease was primarily driven by yield reductions observed at the short and mid end of the yield curve

In Nigeria's sovereign Eurobonds market, a surge in trading activity contributed to a marginal decrease in the average yield, down by 0.01% to 9.94%.

Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 1.38% at the official market, closing at №1,169.99 to the dollar. In the Parallel market, the Naira closed at №1,145 to the dollar.

Global Commodity Market

At 3:30 p.m. GMT+1, Oil prices saw a significant upturn. Brent crude surged by 0.42%, reaching \$87.47 per barrel, also WTI crude experienced an increase, rising by 0.52% to \$83.16 per barrel.
