
# Cowry Daily Market Insight 21 June 2024

ASI Takes a Dip by 0.10% on Weak Market Activities; Naira Falls to ₩1,485.53/USD in Official Market.

The All-Share Index decreased by 0.10%, ending the trading week at 99,743.05 points, as the market saw 26 losers compared to 23 gainers. Similarly, the market capitalization of listed equities fell by 0.10% to N56.42 trillion. Market activity was subdued, indicated by a significant drop in trading volume and value. Total volume and value plummeted by 52.22% and 54.88%, respectively, to 617.22 million units and N11.35 billion. However, the total deals for the day increased by 12.88% to 9,273 deals. Sectoral performance was mostly positive, with the Consumer Goods, Oil/Gas, and Industrial Goods indices rising by 0.16%, 0.12%, and 0.08%, respectively. However, the Banking and Insurance indices declined by 1.26% and 1.46%, respectively. Among individual stocks, INTBREW (10.00%), THOMASWY (9.95%), CHAMS (9.86%), CHAMPION (9.83%), and JOHNHOLT (9.66%) were the top gainers, each showing notable share price increases. On the other hand, MULTIVERSE (-9.68%), RTBRISCOE (-7.46%), SUNUASSUR (-6.25%), NEM (-5.95%), and FIDELITYBANK (-4.81%) led the decliners with significant share price drops. FBNH was the most traded security in terms of both volume and value, with 207.91 million units valued at N4.57 billion, traded across 544 transactions.



### **Money Market**

In the money market, the Overnight NIBOR increased by 143 basis points to reach 26.54%, reflecting tightening liquidity, despite FAAC inflow. Similarly, key money market rates such as the Open Repo Rate (OPR) and Overnight Lending Rate (OVN) increased by 1.54% and 1.49%, closing at 25.25% and 26.04%, respectively.

Meanwhile, NITTY was in the mixed bag reflecting the expectation for Nigerian T-bills auction next week where higher rates and yields are expected at the primary market auction. The average secondary market yield on T-bills rose by 0.04% to reach 19.80%.

#### **Bond Market**

In the FGN bond market, average secondary market yield declined by 0.06% to close at 18.77%.

The sovereign Eurobonds market was predominantly bearish across maturities, thus pushing the average yield higher by 3bps to 10.27%.

### Foreign Exchange Market

In the foreign exchange market, the Naira depreciated against the dollar by 0.01% in the official NAFEM market, closing at №1,485.53 per dollar. At the parallel market, the Naira closed at N1,475 per dollar.

## **Global Commodity Market**

In the global commodity market at 3.30pm GMT +1, Brent crude futures increased by 0.35% to \$85.94 a barrel, while U.S. West Texas Intermediate crude futures advanced by 0.26% to \$81.45 a barrel.
