
Sell-Offs Persist as Equities Market Loses N56.12 billion; NIBOR Declines as Liquidity Conditions Improve....

At the close of Thursday's trading session, the Nigerian equities market faced a notable downturn, reflecting persistent bearish sentiment. The benchmark All-Share Index fell by 0.10%, settling at 97,100.36 points, and the market capitalization of listed equities decreased by 0.10% to N55.13 trillion, resulting in a total market loss of N56.12 billion. The session experienced a severe downturn, with 31 stocks falling sharply compared to only 14 gainers, underscoring a significant bearish trend. Among the major decliners were OANDO (-9.94%), ABCTRANS (-9.52%), GUINEAINS (-9.09%), LIVESTOCK (-9.09%), and ACADEMY (-7.69%), reflecting downward share price adjustments. Trading activity was subdued, with total deals, volume, and value declining significantly by 13.53%, 13.97%, and 35.71%, respectively, to 7,233 deals, 271.26 million units, and N3.52 billion. Despite the overall negative momentum, some sectors showed resilience. The Banking, Insurance, and Oil/Gas indices recorded modest gains of 0.03%, 0.41%, and 2.63%, respectively. Conversely, the Consumer Goods sector declined by 0.60%, driven by losses in DANGSUGAR, UNILEVER, NB, and INTBREW, while the Industrial Goods sector saw a slight drop of 0.004%. On a positive note, several stocks demonstrated strong performance. NEIMETH (+9.55%), TOTAL (+8.82%), AIICO (+6.54%), CILEASING (+6.07%), and UPDC (+4.92%) emerged as the top gainers, reflecting significant share price increases. In terms of trading volume, VERITASKAP led with 33.38 million units traded in 135 deals, while GTCO topped in traded value with transactions amounting to N725.23 million.



Money Market

In the money market, NIBOR rates continued to decline on Thursday due to sustained improvements in liquidity conditions. Specifically, the Overnight, 1-month, 3-month, and 6-month NIBOR rates fell by 208bps, 38bps, 42bps, and 60bps, respectively. Additionally, the Open Repo Rate (OPR) and Overnight Rate (O/N) decreased by 172bps and 183bps, settling at 32.44% and 33.22%, respectively.

The Nigerian Interbank Treasury Bills True Yield (NITTY) experienced a downward trend across most maturities, influenced by sell pressures from traders seeking to capitalize on higher yields elsewhere. Meanwhile, the secondary market for Nigerian Treasury Bills exhibited a bullish trend, with the average yield decreasing by 0.01% to 23.36%.

Bond Market

Trading in the FGN bond market showed positive movement, with the average secondary market yield falling by 0.22% to 19.71%.

In the Nigerian sovereign Eurobonds market, bullish sentiment across segments of the yield curve led to a slight decrease in the average yield, down by 0.01% to 10.44%.

Foreign Exchange Market

In the official NAFEM market, the naira strengthened against the US dollar, appreciating by 1.36% to \$1,564.48 per dollar. In the parallel market, the naira closed at an average of \$1,585 per dollar.

Global Commodity Market

At 3:30 p.m. GMT+1 on Thursday, Brent crude increased by 1.81% to \$81.20 per barrel, and West Texas Intermediate (WTI) crude advanced by 1.69% to \$78.28 per barrel.
