

Market Reverses Trend by 0.23% as Sell Sentiment Drags ASI, Naira Depreciates by 0.28% in FX Market....

The local stock market ended on a bearish note today, as the ASI dropped by 0.23%, settling at 98,003.75 points. This decline triggered a 0.23% reduction in market capitalization, closing at ₹56.32 trillion, resulting in a ₹130.5 billion loss in investor portfolios due to sell-offs. Despite the negative sentiment, 25 stocks gained while 26 stocks saw declines in their share prices. Leading gainers included ABCTRANS, MCNICHOLS, UPL, FIDSON, and CAVERTON, which rose by 10.00%, 10.00%, 9.95%, 9.85%, and 9.80%, respectively. On the losing side, HONYFLOUR (-9.98%), FBNH (-9.88%), UPDC (-9.74%), NSLTECH (-8.82%), and TANTALIZER (-8.82%) were among the major decliners. Sectoral performance was broadly negative, with the Banking sector down 0.62%, Consumer Goods down 0.26%, Industrial down 0.06%, Insurance down 0.57%, and Oil and Gas down 0.13%. Despite the overall bearish trend, trading activity was strong, with the number of deals, volume, and value rising by 2.30%, 30.94%, and 50.13%, respectively, reaching 473.09 million shares valued at ₹11.36 billion across 9,848 transactions.

JAPAULGOLD emerged as the most traded stock, with 106.7 million units worth ₹259.8 million exchanged in 176 deals.



Money Market

NIBOR rates increased across all tenors reflecting system Illiquidity. Likewise, the Open Repo Rate and Overnight Lending Rate increased by 0.17% and 0.27% to 31.45 and 31.83, respectively.

Nigerian Interbank Treasury Bills True Yield (NITTY) witnessed a predominantly downward trend across all maturities. As a result, the average secondary market yield for T-bills rose by 0.45% reaching 18.63% due to sell sentiments.

Bond Market

In the secondary market for FGN Bonds, positive market activity was observed reaching 18.59%.

In Nigeria's sovereign Eurobonds market, sell pressure at the short, mid and long ends of the yield curve led to a 0.17% increase in the average yield to 9.53%.

Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 0.28%, closing at \$1,544.02 per dollar at the official market. In the Parallel market, the Naira closed at \$1,645 to the dollar.

Global Commodity Market

In the global commodity market, oil prices trended higher on Thursday, with Brent Crude at \$74.35 per barrel and WTI at \$71.52 per barrel.
