
The Bullish Party Continues on the NGX with 0.14% ASI Movement, NIBOR Declines on System Liquidity Ease....

The local stock market opened this week's trading session with bullish momentum, as the All-Share Index (ASI) climbed by 0.14% to close at 98,386.60 points. This upward movement was mirrored in the market capitalization, which also rose by 0.14% to ₹56.54 trillion, adding ₹79.7 billion to investors' portfolios.

Consequently, the year-to-date (YTD) return increased to 31.58%. Sectoral performance was mixed: while the insurance, oil and gas, and industrial sectors experienced declines of 0.37%, 0.09%, and 0.07%, respectively, the banking and consumer goods sectors posted gains of 0.95% and 0.24%. The session closed with 32 stocks advancing against 20 declining. FCMB (10.00%), MCNICHOLS (10.00%), FIDELITYBK (9.93%), TANTALIZER (9.84%), and HONYFLOUR (9.81%) led the gainers, while the top losers were BERGER, DAARCOM, DEAPCAP, NSLTECH, and HONYFLOUR. Trading activity was largely positive, with the number of deals and volume rising by 23.06% and 46.23%, reaching 810.43 million units across 10,669 transactions. However, the traded value fell by 18.06%, closing at ₹8.29 billion.

MECURE emerged as the most traded stock, with 400.1 million units worth ₹2.78 billion.



### Money Market

NIBOR rates declined across all tenors reflecting system liquidity. Likewise, the Open Repo Rate and Overnight Lending Rate decreased by 9.54% and 9.17% to 20.15 and 20.80, respectively.

Nigerian Interbank Treasury Bills True Yield (NITTY) witnessed upward movement across all maturities. The average secondary market yield on T-bills increased by 0.04% to 18.63% due to sell sentiments.

### **Bond Market**

In the secondary market for FGN Bond market, there was negative trading activity in the average yield to 18.70%.

In Nigeria's sovereign Eurobonds market, sell pressure at the short, mid and long ends of the yield curve led to a 0.16% increase in the average yield to 9.75%.

## Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 1.37%, closing at ₹1,562.66 per dollar at the official market. In the Parallel market, the Naira closed at ₹1,645 to the dollar.

## Global Commodity Market

In the global commodity market, oil prices trended higher on Monday, with Brent Crude at \$75.03 per barrel and WTI at \$71.73 per barrel.
