

ASI Takes Another Haircut by 1.19% as Investors Rebalance Portfolio, NAIRA appreciated by 0.59% at the official market....

The local stock market extended its bearish trend today, with the All-Share Index (ASI) dropping by 1.19% to close at 97,064.42 points. This decline mirrored a 1.19% fall in market capitalization, which closed at \$\infty\$5.78 trillion, wiping out \$\infty\$671 billion from investor portfolios due to widespread sell-offs. In total, 28 stocks declined in value, while 23 posted gains. Leading the gainers were SEPLAT, LIVESTOCK, REGALINS, CAVERTON, and MANSARD, which saw increases of 10.00%, 9.93%, 9.76%, 9.63%, and 7.62%, respectively. On the losing end, DANGCEM and MCNICHOLS both fell by 10.00%, followed by NSLTECH (-7.58%), UPDCREIT (-4.72%), and CWG (-4.62%). Sector performance was mixed but mostly positive, with gains of 0.03% in the banking sector, 2.00% in insurance, and 3.80% in the oil and gas sector. However, the consumer goods and industrial goods sectors declined by 0.20% and 5.96%, respectively. Trading activity was generally down, as the number of trades, volume, and value dropped by 27.56%, 36.08%, and 18.25%, respectively. Overall, 268.39 million shares valued at \$\infty\$6.76 billion were traded in 8,565 deals. UBA was the most active stock in terms of volume, value, and deals, with 37 million units worth \$\infty\$93.9 million exchanged across 909 deals.



Money Market

In the money market, NIBOR rose across all maturities as money market conditions tightened, with banks holding reserves aiming to capitalize on higher rates. However, Key money market rates such as the Open Repo Rate (OPR) and Overnight Lending Rate (O/N) increased by 4.00% and 3.80% to close at 28.98 and 29.68

Nigerian Interbank Treasury Bills True Yield (NITTY) experienced upward movement across all maturities, while the average secondary market yield on T-bills slightly eased by 0.01%, settling at 20.20%.

Bond Market

In the secondary market for FGN Bond market, negative trading activity led to a 0.25% increase in the average yield, pushing it up to 19.09%.

In Nigeria's sovereign Eurobonds market, sell pressure across the short, mid and long ends of the yield curve resulted in a 0.04% increase in the average yield to 9.62%.

Foreign Exchange Market

In the foreign exchange market, the Naira appreciated by 0.59%, closing at \$1,659.26 per dollar at the official market. In the Parallel market, the Naira closed at \$1,665 to the dollar.

Global Commodity Market

In the global commodity market, oil prices trended higher on Thursday, with Brent Crude at \$76.8 per barrel and WTI at \$73 per barrel.
