

Bearish Outing Continues on the NGX as ASI dips 0.21%; Investors lose N127.3 billion, NITTY fell across all maturities

The local stock market continued its bearish trend today as the ASI fell by 0.21%, closing at 98,081.38 points. This decline resulted in a 0.21% drop in market capitalization, which settled at \$59.43 trillion, causing investors to lose \$127.3 billion due to sell-offs. Despite the negative sentiment, 29 stocks advanced, while 16 declined. Top gainers included GOLDBREW (+10.00%), DEAPCAP (+9.85%), TRANSPOWER (+9.68%), JAIZBANK (+8.64%), and TRANSCOHOT (+7.78%). On the losing side, ARADEL (-10.00%), REGALINS (-8.82%), DAARCOM (-6.78%), UACN (-6.70%), and OANDO (-5.82%) led the declines. Sectoral performance was mostly positive, with the insurance sector gaining 1.13%, consumer goods edging up 0.01%, oil/gas rising 0.92%, and industrial goods inching up 0.08%. However, the banking sector declined by 0.57%. The overall bearish market dampened trading activity, with the number of deals, volume, and value dropping by 9.85%, 30.77%, and 0.21%, respectively. In total, 232.19 million shares were traded across 7,175 deals, totaling \$6.23 billion. STERLINGNG led trading volume with 42.8 million units worth \$213 million traded in 283 deals, while ARADEL topped the value chart.



Money Market

In the money market, NIBOR rose across most maturities signaling Illiquidity in the banking system. However, key money market rates, including the Open Repo Rate (OPR) and the Overnight Lending Rate (O/N), fell by 0.22% and 0.32%, closing at 32.28% and 32.58%, respectively.

Nigerian Interbank Treasury Bills True Yield (NITTY) experienced downward movement across all maturities, while the average secondary market yield on T-bills moderated by 0.03%, settling at 23.52% due to sell-sentiment.

Bond Market

In the secondary market for FGN Bond market, there was negative trading activity which led to a 3bps decrease in the average yield to 19.25%.

In Nigeria's sovereign Eurobonds market, sell pressure across the short, mid and long ends of the yield curve resulted in a 5bps increase leading to an average yield of 9.37%.

Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 0.05%, closing at ₦1,660.49 per dollar at the official market. In the Parallel market, the Naira closed at ₦1,690 to the dollar.

Global Commodity Market

On Thursday, oil prices in the global commodity market rose, with Brent Crude increasing by 0.51% to \$74.6 per barrel, while WTI also dropped by 0.65%, closing at \$70.8 per barrel.
