
## Cowry Daily Market Insight 29 October 2024

Bargain Hunting Activities Wipe N394bn from Investors Pocket, NAIRA Appreciated by 2.41% at the Official Market...

The local stock market continued the week on a bearish note today, as the All-Share Index (ASI) declined by 0.66% to close at 98,058.07 points. This downturn was matched by a 0.66% decrease in market capitalization, which settled at ₦59.42 trillion, leading to investor losses of ₦394.4 billion amid increased sell-offs. Despite the overall negative sentiment, 26 stocks posted gains, while 32 recorded losses. The top gainers included NNFM (+10.00%), EUNISELL (+9.87%), TIP (+9.81%), LIVESTOCK (+7.73%), and CWG (+4.96%). In contrast, CADBURY (-9.89%), ACADEMY (-9.87%), ROYALEX (-9.72%), ARADEL (-8.33%), and SOVRENINS (-8.06%) led the decliners. Sector performance was mixed, with the banking (-1.46%), consumer goods (-0.01%), and industrial goods (-0.33%) sectors recording declines, while the insurance and oil/gas sectors posted modest gains of 0.18% and 0.03%, respectively. Trading activity was robust, with increases of 1.38%, 13.06%, and 96.08% in the number of deals, volume, and value, respectively. In total, 399.32 million shares were traded across 9,547 deals, amounting to ₦8.93 billion. UBA led in trading volume, with 90 million units valued at ₦2.61 billion over 848 deals.



### Money Market

In the money market, NIBOR declined across most maturities, with the Overnight, 3-month, and 6-month tenors falling by 1.30%, 0.52%, and 1.04%, respectively, to settle at 26.58%, 27.58%, and 27.88%. This reflects increased liquidity within the banking system. Additionally, other key rates, such as the Open Repo Rate (OPR) and the Overnight Lending Rate (O/N), also dropped by 0.79% and 0.78%, closing at 26.53% and 26.95%, respectively.

Nigerian Interbank Treasury Bills True Yield (NITTY) experienced upward movement across all maturities, while the average secondary market yield on T-bills moderated by 0.02%, settling at 24.14%.

### Bond Market

In the secondary market for FGN Bond market, trading activity stayed quiet in the average yield to 19.30%.

In Nigeria's sovereign Eurobonds market, sell pressure on Eurobonds maturing in Nov-2025, Nov-2027, Sep-2033, Feb-2038, and Jan-2049 led to a slight increase in yields, bringing the average yield to 9.61%.

### Foreign Exchange Market

In the foreign exchange market, the Naira appreciated by 2.41%, closing at ₦1,630.45 per dollar at the official market. In the Parallel market, the Naira closed at ₦1,725 to the dollar.

### Global Commodity Market

On Tuesday, oil prices in the global commodity market trended higher, with Brent Crude increasing by 0.33% to \$71.7 per barrel, while WTI also rose by 0.33%, closing at \$67.6 per barrel.
