

Tepid Outing as ASI Nosedives by 0.38%; Stock Market Lose N225.4bn, NIBOR fell Across all Maturities Signaling Improved Liquidity in the System...

The local stock market closed the trading session on a bearish note, with the All-Share Index (ASI) declining by 0.38% to close at 97,651.23 points. This downward trend was mirrored in market capitalization, which fell by 0.38% to ₹59.17 trillion, causing investor losses of approximately ₹225.4 billion due to increased sell-offs. Despite the overall negative sentiment, there were 24 advancing stocks, while 26 declined. Leading the gainers were SUNUASSUR, EUNISELL, UPL, CORNEST, and PRESTIGE, whereas the top losers included VERITASKAP, ARADEL, NSLTECH, RTBRISCOE, and BETAGLAS. Sectoral performance was mixed. The consumer goods and industrial goods sectors both recorded declines, falling by 0.06% and 0.09%, respectively. However, the banking, insurance, and oil/gas sectors saw gains, rising by 0.28%, 1.12%, and 1.27% respectively. Trading activity reflected the subdued market sentiment, with the number of deals, trading volume, and value dropping by 9.72%, 0.40%, and 34.57%, respectively. In total, 536.79 million shares were traded across 9,053 deals, amounting to ₹10.01 billion in value. UBA led trading volume with 74.2 million units worth ₹2.19 billion across 512 deals.



### Money Market

In the money market, NIBOR fell across all maturities, signaling improved liquidity in the banking system. Additionally, other key rates, such as the Open Repo Rate (OPR) and the Overnight Lending Rate (O/N), also dropped by 3.71% and 3.55%, closing at 21.14% and 21.45%, respectively.

Nigerian Interbank Treasury Bills True Yield (NITTY) experienced mixed movement all maturities, while the average secondary market yield on T-bills moderated by 0.02%, settling at 24.12%.

### **Bond Market**

In the secondary market for FGN bonds, trading activity was positive, resulting in a 2-basis-point decrease in the average yield, reaching 19.49%.

In Nigeria's sovereign Eurobonds market, sell pressure across the short, mid and long end of the yield curve led to a 0.10% increase in the average yield to 9.63%.

## Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 2.72%, closing at ₦1,675.49 per dollar at the official market. In the Parallel market, the Naira closed at ₦1,726 to the dollar.

## Global Commodity Market

On Thursday, oil prices in the global commodity market trended higher, with Brent Crude increasing by 1.07% to \$72.9 per barrel, while WTI also rose by 1.29%, closing at \$69.5 per barrel.
