

ASI Sees Bearish Start to November with 0.22% as Market Retraces, NAIRA Appreciates by 0.52% at the Official Market....

The local stock market closed the trading week with a bearish outlook as the All-Share Index (ASI) fell by 0.22% to 97,432.02 points. Market capitalization also declined by 0.22% to \\$59.04 trillion, leading to investor losses of approximately \\$132.8 billion due to heightened sell-offs. Despite this, there were 23 advancing stocks against 31 decliners. Leading the gainers were JOHNHOLT, EUNISELL, REDSTAREX, PZ, and LASACO, while ARADEL, ELLAHLAKES, MULTIVERSE, MCNICHOLS, and CUSTODIAN led the decliners. Sectoral performance was mixed: oil/gas and industrial goods sectors dropped by 0.07% and 0.01%, respectively, while banking, insurance, and consumer goods sectors gained by 1.15%, 0.15%, and 0.23%. Trading activity was strong, with volume and value rising by 65.58% and 58.24%, respectively, though the number of trades fell by 2.76%. A total of 888.8 million shares were exchanged across 8,803 deals, totaling \\$15.84 billion in value. FIDELITYBK led in trading volume with 540 million units valued at \\$7.69 billion across 344 deals.





Money Market

In the money market, NIBOR increased across all maturities, except for the Overnight NIBOR, which declined, indicating improved liquidity in the banking system. Additionally, other key rates, including the Open Repo Rate (OPR) and the Overnight Lending Rate (O/N), dropped by 1.89% and 1.77%, closing at 19.25% and 19.68%, respectively.

The Nigerian Interbank Treasury Bills True Yield (NITTY) saw an increase across most maturities, while the average secondary market yield on T-bills eased by 0.05%, settling at 24.22%.

Bond Market

In the secondary market for FGN bonds, trading activity stayed quiet in the average yield, to 19.49%.

In Nigeria's sovereign Eurobonds market, sell pressure across the short, mid and long end of the yield curve led to a 0.09% rise in the average yield, bringing it to 9.73%.

Foreign Exchange Market

In the foreign exchange market, the Naira appreciated by 0.52%, closing at ₦1,666.72 per dollar at the official market. In the Parallel market, the Naira closed at ₦1,730 to the dollar.

Global Commodity Market

On Friday, oil prices in the global commodity market trended higher, with Brent Crude increasing by 1.46% to \$73.9 per barrel, while WTI also rose by 1.61%, closing at \$70.4 per barrel.
