

Bulls Resurface by 22bps on Upbeat Trading Activities Following 6 Days of See-Saw Movements, NAIRA Appreciates by 0.33% at the Official Market....

The local bourse closed today's trading session on a bullish note, with the All-Share Index (ASI) rising by 0.22% to 97,123.61 points. This gain boosted market capitalization by 0.22% to \$458.85 trillion, adding \$4130.8 billion to investors' portfolios and bringing the year-to-date (YTD) return to 29.89%. Sector performance was largely negative, as insurance fell by 1.33%, consumer goods by 0.05%, and industrial goods by 0.06%. However, the banking and oil/gas sectors rose by 3.16% and 1.55%, respectively. Overall, 26 stocks advanced while 21 declined. Leading gainers included CONOIL (+9.93%), JOHNHOLT (+9.92%), UBA (+9.87%), EUNISELL (+9.87%), and PZ (+8.48%), while prominent decliners included OANDO, DAARCOM, REGALINS, VERITASKAP, and GUINEAINS. Trading activity was strong, with increases in deals, volume, and value by 2.82%, 194.37%, and 79.64%, respectively. A total of 3,602.24 million shares were traded in 10,679 deals, amounting to \$425.57\$ billion. SOVRENINS led by volume, with 2.5 billion units valued at \$41.42\$ million across 12 transactions.



Money Market

In the money market, NIBOR rose across all maturities, indicating tight liquidity in the banking system. Additionally, other key rates showed movement: the Open Repo Rate (OPR) and the Overnight Lending Rate (O/N) increased by 10.59% and 10.67%, closing at 29.81% and 30.36%, respectively.

The Nigerian Interbank Treasury Bills True Yield (NITTY) declined across all maturities, while the average secondary market yield on T-bills eased by 0.01%, settling at 23.94%.

Bond Market

Negative trading activity in the secondary market for FGN bonds led to a slight increase in the average yield, reaching 19.46%.

Mixed sentiment across the short, mid, and long ends of the yield curve led to muted activity in Nigeria's sovereign Eurobonds market.

Foreign Exchange Market

In the foreign exchange market, the Naira appreciated by 0.33%, closing at ₩1,671.32 per dollar at the official market. In the Parallel market, the Naira closed at ₩1,710 to the dollar.

Global Commodity Market

On Tuesday, oil prices in the global commodity market trended higher, with Brent Crude increasing by 0.75% to \$75.6 per barrel, while WTI also rose by 0.87%, closing at \$72.1 per barrel.
