

Bears Halt Bullish Run Amidst Robust Trading Activities; ASI Slips by 0.18%, NAIRA Strengthens by 1.71% Against the Dollar at the Official Market

The local stock exchange closed today's session on a bearish note, as the All-Share Index (ASI) dropped by 0.18% to settle at 98,050.12 points. This decline resulted in a N107.5 billion reduction in market capitalization, bringing it to N59.43 trillion. Despite this, the year-to-date (YTD) return remained robust at 31.13%. Sectoral performance was mixed but leaned positive, with the insurance (+0.26%), consumer goods (+0.39%), and industrial (+0.21%) sectors recording gains, while the banking (-1.16%) and oil/gas (-0.33%) sectors declined. Market breadth favored the bulls, as 35 stocks advanced, outpacing 24 decliners. Notable gainers included AUSTINLAZ, EUNISELL, HMCALL, HONYFLOUR, and SUNUASSUR, while UPL, SOVRENINS, UNVINSURE, JAPAULGOLD, and OANDO led the laggards. Trading activity was vibrant, with increases of 4.68%, 23.2%, and 9.15% in the number of deals, trading volume, and trade value, respectively. A total of 456.83 million shares worth N9.22 billion were exchanged in 10,495 deals. FBNH emerged as the most actively traded stock by volume, with 51 million units valued at N1.38 billion changing hands across 263 transactions.



Money Market

In the money market, the Nigerian Interbank Offered Rate (NIBOR) decreased across the 1-month, 3-month, and 6-month tenors, while the Overnight NIBOR increased by 331 basis points, indicating the system's liquidity levels. Similarly, the Open Repo Rate (OPR) and Overnight Lending Rate (O/N) rose significantly by 0.55% and 0.58%, respectively, reaching 32.25% and 32.83%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) recorded decreases across most maturities, whereas the average secondary market yield on Treasury bills declined slightly by 0.01%, closing at 24.07%.

Bond Market

Trading activity in the secondary market for FGN bonds stayed quiet in the average yield, bringing it to 19.41%.

In Nigeria's sovereign Eurobonds market, sell pressure across the short, mid, and long segments of the yield curve caused the average yield to increase by 0.02%, settling at 9.74%.

Foreign Exchange Market

In the foreign exchange market, the Naira appreciated by 1.71%, closing at \$1,658.67 per dollar at the official market. In the Parallel market, the Naira closed at \$1,740 to the dollar.

Global Commodity Market

Global oil prices saw an uptick on Thursday in the commodity market. Brent Crude climbed by 1.81%, reaching \$74.13 per barrel, while West Texas Intermediate (WTI) advanced by 2.02% to \$70.14 per barrel.
