

Local Bourse Snaps a Lull Reversal WithN8.2bn Gains for Market Cap, NIBOR Increases Across Most Maturities Signaling Illiquidity in the Banking System....

The local stock exchange closed today's trading session on a positive note, as the All-Share Index (ASI) edged up by 0.01% to settle at 97,639.88 points. This modest gain added N8.2 billion to the market capitalization, lifting it to N59.18 trillion. The year-to-date (YTD) return also saw a slight increase to 30.58%. Sectoral performance was mostly positive, with gains recorded in the Insurance (+0.91%), Consumer Goods (+0.09%), Oil/Gas (+0.36%), and Industrial Goods (+0.76%) sectors. However, the Banking sector dipped by 0.21%. Market breadth leaned toward the bears, as 24 stocks advanced while 25 declined. Top gainers included HMCALL, SUNUASSUR, JAPAULGOLD, PRESTIGE, and NEIMETH, whereas MULTIVERSE, TANTALIZER, UPDCREIT, UNIVINSURE, and RTBRISCOE led the decliners' chart. Trading activity was subdued, with declines in the number of deals (-11.08%), trading volume (-17.75%), and trade value (-24.52%). A total of 552.11 million shares worth ₩8.03 billion were exchanged across 9,305 transactions. HMCALL emerged as the most actively traded stock, recording 177.1 million shares billion worth ₩1.1 in 43 deals recording 177.1 million shares worth ₩1.1 billion in 43 deals.



Money Market

In the money market, the Nigerian Interbank Offered Rate (NIBOR) increased across most maturities, indicating tight liquidity conditions within the banking system. Meanwhile, the Open Repo Rate (OPR) decreased by 0.06% to 32.00%, while the Overnight Lending Rate (O/N) rose by 0.15%, closing at 32.71%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) experienced upward movements across all maturities. Similarly, the average secondary market yield on Treasury bills rose by 0.05%, reaching 24.04%, driven by sell-side sentiments.

Bond Market

Trading activity in the secondary market for FGN bonds remained subdued, with the average yield settling at 19.41%.

In Nigeria's sovereign Eurobonds market, sell pressure across the short, mid, and long segments of the yield curve led to a 0.04% increase in the average yield, bringing it to 9.67%.

Foreign Exchange Market

In the foreign exchange market, the Naira appreciated by 0.97%, closing at ₦1,659.44 per dollar in the official market, while in the parallel market, it closed at ₦1,745 per dollar.

Global Commodity Market

On Tuesday, global oil prices recorded gains, as Brent Crude rose by 0.89% to \$73.66 per barrel, while West Texas Intermediate (WTI) increased by 0.84% to \$69.52 per barrel.
