

Bearish Close: Market Sheds N208 billion as ASI Slips 0.35%, NIBOR Increases Across All Maturities Signaling Illiquidity in the Banking System....

The local stock market closed today's trading session on a bearish note, as the All-Share Index (ASI) fell by 0.35% to 97,296.57 points. Market capitalization also declined by 0.35% to ₹58.97 trillion, resulting in investor losses of approximately ₹208 billion due to intensified sell-offs. Despite the overall drop, there were 23 gainers compared to 26 losers. Among the top gainers

were SUNUASSUR, GUINEAINS, CONOIL, DAARCOMM, and NASCON, which recorded share price increases of 9.97%, 8.16%, 6.56%, 6.56%, and 6.23%, respectively. Conversely, the top decliners included JOHNHOLT, ARADEL, ETERNA, HMCALL, and UPDC, with share price decreases of 10.00%, 9.98%, 9.88%, 8.43%, and 8.13%. Sectoral performance was mixed but leaned positive: the banking, insurance, oil & gas, and industrial goods sectors posted gains of 0.14%, 1.24%, 1.02%, and 0.02%, respectively, while the consumer goods sector saw a decline of 0.34%. Trading activity remained robust, with increases of 0.86%, 48.97%, and 28.07% in the number of deals, trading volume, and value, respectively. A total of 822.46 million shares were traded across 9,385 deals, amounting to \mathbb{H}10.29 billion. HMCALL dominated in both trading volume and value, with 373.7 million units worth \mathbb{H}2.2 billion exchanged in 342 deals.



Money Market

In the money market, the Nigerian Interbank Offered Rate (NIBOR) rose across all maturities, reflecting tighter liquidity conditions in the banking system. In contrast, the Open Repo Rate (OPR) and Overnight Lending Rate (O/N) declined by 0.21% and 0.22%, settling at 31.78% and 32.50%, respectively.

The Nigerian Interbank Treasury Bills True Yield (NITTY) increased across all maturities. Likewise, the average secondary market yield on Treasury bills climbed by 1.08% to 25.12%, reflecting prevailing sell-side pressures.

Bond Market

Trading activity in the secondary market for FGN bonds was bearish, resulting in a 0.05% rise in the average yield to 19.45%.

In Nigeria's sovereign Eurobonds market, buy pressure across the short, mid, and long segments of the yield curve caused the average yield to decline by 0.01%, settling at 9.66%.

Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 0.08%, closing at \\ \mathbf{1},660.83 per dollar in the official market, while in the parallel market, it closed at \\ \mathbf{1},735 per dollar.

Global Commodity Market

On Wednesday, global oil prices recorded decreases, as Brent Crude dipped by 0.24% to \$72.6 per barrel, while West Texas Intermediate (WTI) fell by 0.14% to \$68.68 per barrel.
