
Market Retraces Steps by 0.06% from Renewed Bargain Hunting, Overnight NIBOR Falls, Signaling Liquidity in the System ....

The local stock market concluded today's trading session on a bearish note, as the All-Share Index (ASI) slipped by 0.06% to close at 98,114.11 points. Market capitalization mirrored this decline, shedding 0.06% to settle at \\$59.48 trillion, equivalent to investor losses of approximately \\$36.9 billion due to intensified sell-offs. Despite the downturn, 35 stocks recorded gains, with top performers including CORNEST (+10.00%), UPL (+10.00%), STERLINGNG (+9.98%), SUNUASSUR (+9.98%), and GOLDBREW (+9.84%).

Conversely, 16 stocks posted losses, led by REDSTAREX (-10.00%), FTNCOCOA (-5.61%), NPFMCRFBK (-3.23%), NEIMETH (-2.78%), and PRESTIGE (-2.50%). Sectoral performance was mixed but leaned slightly positive. While the banking and industrial goods sectors declined by 0.26% and 0.24%, respectively, the insurance, consumer goods, and oil/gas sectors fell by 3.13%, 0.02%, and 1.13%.

Trading activity showed subdued momentum, with the number of deals and trading value decreasing by 9.82% and 35.58%, respectively. However, trading volume rose significantly, surging by 38.53%. In total, 723 million shares valued at \\$12.84 billion were traded across 8,495 deals. CHAMPION dominated trading volume, with 300 million shares worth \\$1.2 billion exchanged in 28 deals, while GTCO emerged as the leader in trading value.





#### **Money Market**

In the money market, the Nigerian Interbank Offered Rate (NIBOR) increased across most maturities, with the exception of the Overnight NIBOR, which saw a decline, signaling adequate liquidity within the banking system. Similarly, the Open Repo Rate (OPR) and the Overnight Lending Rate (O/N) both rose by 0.50% and 0.75%, respectively, closing at 26.86% and 27.46%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) saw declines across most maturities. In a similar trend, the average secondary market yield on Treasury bills increased by 0.33%, reaching 25.70%, driven by sell-off sentiments.

#### **Bond Market**

Trading activity in the secondary market for FGN bonds was positive, leading to a slight decrease in the average yield, which dropped to 19.48%.

In Nigeria's sovereign Eurobonds market, strong buy pressure across the short, mid, and long segments of the yield curve led to a 0.20% decrease in the average yield, which now stands at 9.26%.

### Foreign Exchange Market

In the foreign exchange market, the Naira held steady, closing at \\ \mathbf{1},672.69 \text{ per dollar in the official market, reflecting no change from the previous rate. Meanwhile, in the parallel market, it ended the day at \\ \mathbf{1},670 \text{ per dollar.}

### **Global Commodity Market**

Global oil prices experienced mixed movements on Thursday, with Brent Crude decreasing by 0.07% to \$72.26 per barrel and West Texas Intermediate (WTI) rising by 0.02% to \$68.55 per barrel.
