



Sell-offs on Industrial Stocks Halt Bullish Streak as ASI Faulters by 0.12%, Naira Appreciates by 0.03% Against the Dollar at the Official Market

The local stock market opened this week on a bearish note, with the All-Share Index (ASI) dipping by 0.12% to close at 101,129.09 points. Market capitalization followed suit, decreasing by 0.12% to N61.3 trillion, translating to investor losses of approximately N72.1 billion due to heightened sell-offs. Despite the negative trend, 39 stocks recorded gains, led by top performers such as UACN (+10.00%), HONYFLOUR (+10.00%), UNIVINSURE (+10.00%), LEARNAFRICA (+9.92%), and NAHCO (+9.89%). Conversely, 15 stocks suffered losses, with MULTIVERSE (-9.80%), ARADEL (-9.80%), INTENEGINS (-8.13%), WAPIC (-4.49%), and NB (-3.33%) as the biggest laggards. Sectoral performance remained mixed, with the banking, insurance, consumer goods, and oil/gas sectors posting gains of 1.65%, 1.05%, 1.03%, and 0.31%, respectively, while the industrial goods sector declined by 0.31%. Trading activity exhibited strong momentum, with the number of deals and traded volumes rising by 42.98% and 63.46%, respectively, although the total trading value declined sharply by 30.53%. In total, 515.56 million shares worth N16.49 billion were traded across 11,554 deals. ZENITHBANK led trading activity, accounting for 60.4 million shares worth ₦2.7 billion traded in 498 deals, while ARADEL dominated in trading value.



Money Market

The money market reflected liquidity in the system, driven by FAAC inflows, as the Nigerian Interbank Offered Rate (NIBOR) declined across most maturities. However, the Open Repo Rate (OPR) declined by 0.50% to 31.79%, while the Overnight Lending Rate (O/N) decreased by 0.46% to 32.33%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) rose across most maturities, while the average secondary market yield on Treasury bills remained steady at 25.70%.

Bond Market

Trading activity in the secondary market for FGN bonds stayed muted in the average yield, which settled at 19.73%.

In Nigeria's sovereign Eurobonds market, buy pressure across the mid and long ends of the yield curve led to a marginal decrease in the average yield to 9.64%.

Foreign Exchange Market

In the foreign exchange market, the Naira appreciated by 0.03%, closing at \$1,536.93 per dollar in the official market. Meanwhile, in the parallel market, it ended the day at \$1,603 per dollar.

Global Commodity Market

Global oil prices rose on Friday, with Brent Crude decreasing by 0.01% to \$72.9 per barrel and West Texas Intermediate (WTI) increasing 0.08% to \$69.4 per barrel.
