


Bargain Hunting Prompts a 0.05% Haircut in NGX-ASI on Post-Christmas Blues, Naira Appreciates by 0.30% Against the Dollar at the Official Market

The local stock market closed the week on a bearish note as the All-Share Index (ASI) declined by 0.05% to settle at 102,133.30 points. Similarly, market capitalization dropped by 0.05% to N61.91 trillion, equating to investor losses of approximately N40 billion due to increased sell-offs. Despite the negative trend, 45 stocks recorded gains, led by top performers such as UNIVINSURE (+10.00%), IKEJAHOTEL (+9.95%), MAYBAKER (+9.94%), SKYAVN (+9.93%), and JOHNHOLT (+9.92%). Conversely, 18 stocks posted losses, with HONYFLOUR (-9.09%), RTBRISCOE (-5.66%), NEIMETH (-5.47%), ETERNA (-5.00%), and TANTALIZER (-4.44%) emerging as the biggest laggards. Sectoral performance was mixed, as the insurance (+2.31%), consumer goods (+0.15%), and industrial goods (+0.01%) sectors recorded gains, while the banking (-1.16%) and oil/gas (-0.21%) sectors declined. Trading activity demonstrated strong momentum, with the number of deals and traded volumes increasing by 49.97% and 4.62%, respectively. However, the total trading value dropped significantly by 4.24%. Overall, 451.73 million shares worth N17.49 billion were traded across 12,551 deals. UBA led the trading activity, contributing 41.7 million shares valued at N1.5 billion across 838 deals.



Money Market

The money market showed signs of illiquidity as the Overnight NIBOR rose. However, the Open Repo Rate (OPR) declined by 0.33% to 26.50%, while the Overnight Lending Rate (O/N) decreased by 0.47% to 27.11%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) rose across most maturities, while the average secondary market yield on Treasury bills moderated by 0.08% to settle at 25.49%.

Bond Market

Trading activity in the secondary market for FGN bonds was subdued, resulting in a slight uptick in the average yield to 19.75%.

In Nigeria's sovereign Eurobonds market, sell pressure across the short, mid and long ends of the yield curve led to a marginal increase in the average yield to 9.67%.

Foreign Exchange Market

In the foreign exchange market, the Naira appreciated by 0.30%, closing at \$1,534 per dollar in the official market. Meanwhile, in the parallel market, it ended the day at \$1,670 per dollar.

Global Commodity Market

Global oil prices rose on Friday, with Brent Crude increasing by 0.97% to \$73.97 per barrel and West Texas Intermediate (WTI) increasing 1.09% to \$70.38 per barrel.
