

Bulls Tighten Grip by 0.99% in Year-End Window-Dressing...Investors Gain N987bn, NIBOR Declines Across All Maturities Signaling Liquidity in the Banking System

The local stock exchange ended today's trading session on a positive trajectory, with the All-Share Index (ASI) advancing by 0.99% to close at 103,149.35 points. This increase added \$987 billion to the market capitalization, raising it to \$62.9 trillion and driving the year-to-date (YTD) return to 37.695%. Sectoral indices showed mixed performance, with gains recorded in insurance (+2.45%), consumer goods (+1.76%) and industrial goods (+0.01%). While, the banking and oil/gas sector declined by 0.42% and 0.35%. Market sentiment remained optimistic, as 39 stocks appreciated compared to 21 decliners. Leading the gainers were MECURE, PRESTIGE, NEIMETH, LASACO, and LIVINGTRUST, while THOMASWY, CAVERTON, WAPIC, HMCALL, and LIVESTOCK. Trading activity was robust, with the number of deals and trading volume increasing by 7.55% and 36.78%, respectively. However, trading value fell by 14.05%. In total, 617.86 million shares worth \$15.03 billion changed hands across 13,499 transactions, with UNIVINSURE leading in trading volume, trading 71 million shares worth \$41 million across 259 deals.



Money Market

The money market showed signs of Liquidity as NIBOR declined across all maturities. However, the Open Repo Rate (OPR) remained steady at 0% to 26.50%, while the Overnight Lending Rate (O/N) increased by 0.03% to 27.14%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) declined across most maturities, while the average secondary market yield on Treasury bills moderated by 0.02% to settle at 25.48%.

Bond Market

Trading activity in the secondary market for FGN bonds stayed muted in the average yield to 19.75%.

In Nigeria's sovereign Eurobonds market, sell pressure across the short, mid and long ends of the yield curve led to a 0.03% increase in the average yield to 9.69%.

Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 0.30%, closing at \$1,538.55 per dollar in the official market. Meanwhile, in the parallel market, it ended the day at \$1,670 per dollar.

Global Commodity Market

Global oil prices rose on Monday, with Brent Crude increasing by 0.97% to \$73.97 per barrel and West Texas Intermediate (WTI) increasing 1.09% to \$70.38 per barrel.
