

Cowry Daily Market Insight 29 January 2025

Rebounds in Midweek Trading by 0.57% as Market Cap Nears N65trn, Naira Appreciates by 0.79% at the Official Market....

The local stock market closed midweek on a positive note, as the All-Share Index gained 0.57% to settle at 104,549.74 points, pushing the year-to-date return to 1.58%. Market capitalization mirrored this growth, rising by 0.57% to N64.52 trillion, driven by the release of full-year 2024 financial results from listed companies. This added N364.7 billion in gains to the equities market by the end of the session. Despite the overall positive sentiment, market breadth remained negative, with 38 decliners outpacing 26 advancers. Leading the gainers were ARADEL, CHELLARAM, STANBIC, UPL, and DAARCOMM, which surged by 10.00%, 9.98%, 9.92%, 9.64%, and 9.09%, respectively. On the flip side, MCNICHOLS and CAVERTON led the laggards with a 10.00% decline each, followed by THOMASWY (-9.80%), VERITASKAP (-9.79%), and CONHALLPLC (-9.00%). Sectoral performance was largely positive, with the Banking, Consumer Goods, Oil & Gas, Industrial Goods, and Commodity indices posting gains of 0.75%, 0.81%, 3.34%, 0.01%, and 1.91%, respectively. However, the Insurance sector declined by 1.65%. Trading activity remained robust, as the number of deals and total value traded increased by 4.47% and 9.99% to 16,256 deals and N15 billion, respectively. Conversely, total volume fell by 22.24% to 42.162 million units. UNIVINSURE was the most traded stock by volume, with 33.6 million units exchanged across 189 deals, while ARADEL led in value, contributing N6.3 billion to the day's transactions.



Money Market

In the money market, the Nigerian Interbank Offered Rate (NIBOR) displayed mixed trends across tenors. The overnight and 6-month rates increased by 0.81% and 0.15%, closing at 27.67% and 29.08%, respectively. Conversely, the 1-month and 3-month rates declined by 0.11% and 0.27%, settling at 27.25% and 28.18%, respectively. Similarly, key money market indicators, including the Open Repo Rate (OPR) and the Overnight Lending Rate, rose by 0.44% and 0.50%, closing at 26.94% and 27.50%, respectively.

The Nigerian Interbank Treasury Bills True Yield (NITTY) declined across all maturities due to strong investor sell pressure. Similarly, the secondary market for Nigerian Treasury Bills experienced bullish momentum, as heightened investor sentiment drove a 1.33% decrease in the average yield, closing at 23.44%.

Bond Market

The secondary market for FGN bonds demonstrated positive momentum, as the average yield declined by 0.01% to close at 20.70%.

Bullish sentiment across Nigeria's sovereign Eurobonds market, spanning the short, mid, and long ends of the yield curve, resulted in a 5-basis-point decline in the average yield, which settled at 9.38%.

Foreign Exchange Market

In the foreign exchange market, the Naira appreciated by 0.79% in the official window, closing at ₦1,510.72 per dollar. Similarly, the Naira ended the day at ₦1,623 per dollar in the parallel market.

Global Commodity Market

In the global commodity market, oil prices fell on Wednesday, with Brent Crude decreasing by 0.34% to settle at \$77.23 per barrel, while West Texas Intermediate (WTI) declined by 0.33% to close at \$73.52 per barrel.
