





Equities Market Slips as Investors Lose N159.5 Billion, Naira Appreciates by 1.76% Against the dollar at the Official Market....

At the close of this week's trading session, the local stock market experienced a downturn, with the All-Share Index declining by 0.24% to settle at 104,496.12 points. This decline resulted in a 0.25% drop in the market capitalization of listed equities, reducing it to N64.71 trillion and erasing N159.5 billion from investors' portfolios. The bearish sentiment was widespread, with significant losses across multiple sectors. The Oil/Gas sector suffered the steepest decline, falling by 1.28%, primarily driven by a notable drop in OANDO's share price. The Banking and Insurance sectors also recorded losses, declining by 1.15% and 0.48%, respectively. On the other hand, the Consumer Goods and Industrial Goods sectors provided some stability, posting modest gains of 0.78% and 0.08%, while the Commodity Index remained unchanged at 0%. Despite the overall market downturn, market breadth remained positive, with 38 stocks advancing compared to 28 decliners. Leading the gainers were BETAGLAS, VITAFOAM, NNFM, CHELLARAM, and TIP, posting share price increases of 10.00%, 9.98%, 9.93%, and 9.90%, respectively. Meanwhile, the biggest decliners included OANDO, STANBIC, IKEJAHOTEL, UPDC, and REGALINS, with losses of 10.00%, 9.94%, 9.84%, 9.66%, and 9.21%, respectively. Trading activity was strong, with the number of deals, trading volume, and value rising by 6.01%, 154.37%, and 30.24%, respectively. A total of 1,265.15 million shares valued at N15.42 billion were exchanged across 14,540 transactions. NSLTECH emerged as the most actively traded stock by volume, with 599 million units worth N413.8 million changing hands in 110 deals, while FBNH led in terms of trade value.



Money Market

In the money market, the Nigerian Interbank Offered Rate (NIBOR) showed a mixed trend across all tenors. Likewise, key money market indicators, such as the Open Repo Rate (OPR) and the Overnight Lending Rate, increased by 2.56% and 2.57%, respectively, closing at 29.14% and 29.57%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) showed a mixed trend across most maturities, driven by strong investor sell pressure. Similarly, the secondary market for Nigerian Treasury Bills witnessed bearish momentum, as heightened investor sentiment led to a 0.01% increase in the average yield, closing at 23.43%.

Bond Market

The secondary market for FGN bonds demonstrated positive momentum, as the average yield declined by 2.84% to close at 17.78%.

Bullish sentiment across Nigeria's sovereign Eurobonds market, spanning the short, mid, and long ends of the yield curve, resulted in a 3-basis-point decline in the average yield, which settled at 9.32%.

Foreign Exchange Market

In the foreign exchange market, the Naira appreciated by 1.76% in the official window, closing at \$1,474.78 per dollar. Similarly, the Naira ended the day at \$1,575 per dollar in the parallel market.

Global Commodity Market

In the global commodity market, oil prices rose on Thursday, with Brent Crude increasing by 0.03% to settle at \$75.91 per barrel, while West Texas Intermediate (WTI) increased by 0.06% to close at \$72.78 per barrel.
