

Nigerian Bourse Maintains Winning Streak with 0.10% ASI Uptick, NIBOR Declines Across All Tenors Signaling Improved Liquidity in the System ...

Equities Market Summary

The local stock market sustained its upward momentum this week, as the All-Share Index (ASI) edged up by 0.10% to close at 105,430.15 points, bringing the year-to-date return to 2.43%. Market capitalization mirrored this growth, rising by 0.10% to N65.29 trillion, adding N65.2 billion in gains to the equities market by the session's close. Buoyed by the market's positive performance, market breadth remained strong, with 33 stocks advancing while 23 declined. Leading the gainers were ETERNA, CADBURY, FIDSON, UPDC, and DEAPCAP, posting gains of 9.88%, 9.88%, 9.77%, 9.77%, and 9.38%, respectively. Conversely, TRIPPLEG, GOLDBREW, VERITASKAP, CAVERTON, and REGALINS topped the list of laggards. Sectoral performance was robust, with the Banking, Insurance, Consumer Goods, Oil & Gas, and Industrial Goods sectors posting gains of 0.09%, 0.63%, 0.18%, 0.13%, and 0.04%, respectively. Meanwhile, the Commodity Index remained unchanged at 0%. Trading activity was subdued, as total volume and value declined by 49.19% and 20.09%, respectively, to 537.19 million units valued at N23.03 billion. However, the number of deals surged by 2.45% to 15,450 transactions.

Money Market

In the money market, the Nigerian Interbank Offered Rate (NIBOR) declined, reflecting improved liquidity conditions within the banking system. Meanwhile, key money market indicators trended upward, with the Open Repo Rate (OPR) and Overnight Lending Rate rising by 0.19% and 0.65%, respectively, to close at 32.29% and 32.65%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) trended downward across most maturities, driven by investor sell-offs. Similarly, the secondary market for Nigerian Treasury Bills experienced bullish momentum, as heightened investor demand led to a 0.57% decline in the average yield, closing at 22.60%.

Bond Market

The secondary market for FGN bonds maintained positive momentum, with the average yield edging down by 0.05% to close at 20.57%.

Bullish sentiment across Nigeria's sovereign Eurobonds market, spanning mid-, and long-term maturities, drove a 1-basis-point decline in the average yield, closing at 9.23%.

Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 0.06% in the official window, closing at \$1,500.65 per dollar. Similarly, the Naira ended the day at \$1,575 per dollar in the parallel market.




