

Equities Market Summary

At the close of this week's trading session, the local stock market experienced a downturn, as the All-Share Index fell by 1.02% to 108,053.95 points. This decline also led to a 1.02% drop in the market capitalization of listed equities, reducing it to \\ 67.42 trillion and wiping \\ 697.6 billion from investors' portfolios. Bearish sentiment was widespread, with significant losses across multiple sectors. The Consumer Goods sector suffered the steepest decline, dropping 5.01%, largely due to a notable fall in BUA FOODS' share price. The Oil & Gas sector followed with a 2.34% decline, while the Banking, Insurance, and Commodity sectors lost 0.75%, 0.15%, and 1.36%, respectively. In contrast, the Industrial Goods sector provided some stability, posting a modest 0.78% gain. Despite the overall downturn, market breadth remained positive, with 38 stocks advancing against 28 decliners. ROYALEX, UPDC, TIP, REDSTAREX, and CWG led the gainers with price increases of 10.00%, 9.88%, 9.76%, 9.09%, and 7.41%, respectively. On the flip side, the biggest decliners included BUAFOODS, DAARCOMM, ARADEL, LIVESTOCK, and BETAGLASS, shedding 10.00%, 9.09%, 6.90%, 6.09%, and 5.74%, respectively. Trading activity was strong, with trading volume and value rising by 12.10% and 51.22%, respectively, even as the number of deals declined by 4.46%. A total of 478.76 million shares worth \(\frac{1}{2}\)13.91 billion were exchanged across 15,613 transactions.

Money Market

In the money market, the Nigerian Interbank Offered Rate (NIBOR) exhibited mixed movements across all tenors. Meanwhile, key money market indicators trended upward, with the Open Repo Rate (OPR) and the Overnight Lending Rate rising by 0.07% and 0.05% to 32.45% and 32.80%, respectively.

The Nigerian Interbank Treasury Bills True Yield (NITTY) showed mixed movements across all maturities. Likewise, the secondary market for Nigerian Treasury Bills witnessed bullish momentum, driven by heightened investor demand, which resulted in a 0.01% decline in the average yield to 22.08%.

Bond Market

The secondary market for FGN bonds witnessed a positive trend, with the average yield declining by 0.09% to 20.25%.

Bullish sentiment across Nigeria's sovereign Eurobonds market, covering short-, mid-, and long-term maturities, led to a 0.05% decrease in the average yield, closing at 9.07%.

Foreign Exchange Market

In the foreign exchange market, the Naira appreciated by 0.36% in the official window, closing at \$1,509.70 per dollar. Similarly, the Naira ended the day at \$1,555 per dollar in the parallel market.




