## Equities Market Summary

On Tuesday, the local bourse extended its downward trend as the All-Share Index declined by 0.32% to 107,781.61 points. This decline resulted in a corresponding 0.32% drop in the market capitalization of listed equities, reducing it to ₦67.17 trillion and wiping out ₦215 billion from investors' portfolios. Sectoral performance was predominantly negative, with losses recorded across major sectors: Banking (-0.56%), Insurance (-3.52%), Consumer Goods (-0.22%), Oil & Gas (-1.04%), while the Industrial Goods and Commodity Index each dipped by 0.02%. Market breadth reflected the overall downturn, as 49 stocks closed lower against only 13 gainers. Leading the advancers were SMURFIT, NGXGROUP, REDSTAREX, ABCTRANS, and NPFMCRFBK, while HONYFLOUR, MORISON, UPL, INTENEGINS, and OANDO topped the list of decliners. Despite the negative sentiment, trading activity remained strong, with trading volume and value rising by 1.47% and 9.85%, respectively, even as the number of deals declined by 13.58%. A total of 363.01 million shares worth ₦10.12 billion were exchanged across 13,753 transactions.

## Money Market

In the money market, the Nigerian Interbank Offered Rate (NIBOR) trended downward across all tenors, indicating improved liquidity conditions in the banking system. Similarly, key money market indicators showed an upward movement, with the Open Repo Rate (OPR) decreasing by 2.40% to 30.00% and the Overnight Lending Rate decreasing by 2.33% to 30.57%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) saw a decrease across most maturities. Similarly, the secondary market for Nigerian Treasury Bills gained bullish momentum, with increased investor demand causing the average yield to decline by 0.03%, settling at 19.96%.

## Bond Market

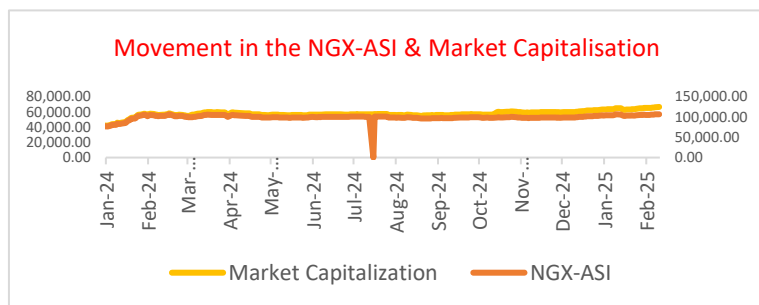
The secondary market for FGN bonds showed a positive trend, with the average yield experiencing an increase of 0.43% to 19.08%.

Mixed sentiment across Nigeria's sovereign Eurobonds market, covering short-, mid-, and long-term maturities, led to a marginal decrease in the average yield, closing at 8.97%.

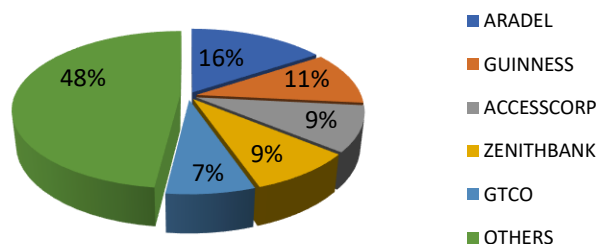
## Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 0.15% in the official window, closing at ₦1,501.42 per dollar. Similarly, the Naira ended the day at ₦1,490 per dollar in the parallel market.

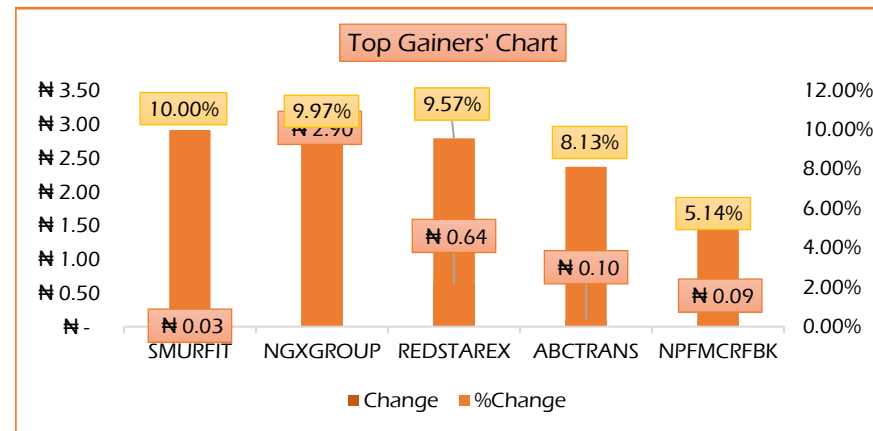

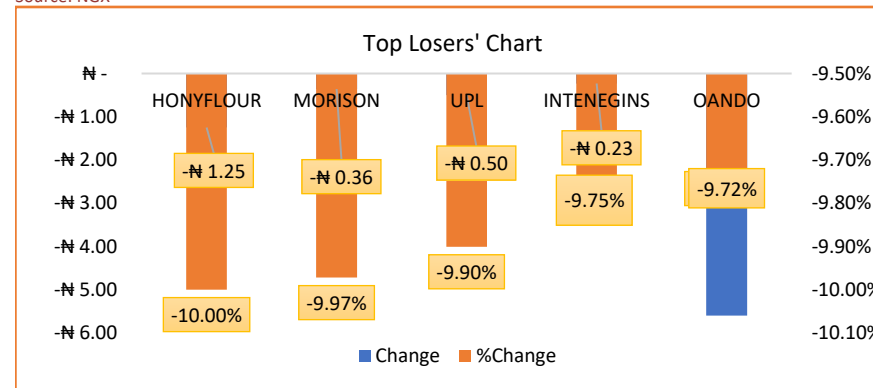

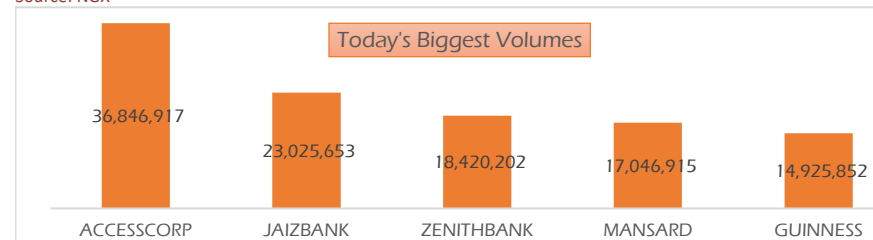
