

Losing Streak Lingers as Market Sentiments Stay Weak, ASI Slips 0.51%, NIBOR Declines Across all Tenors Indicating Improved Liquidity Conditions ...

## **Equities Market Summary**

The local stock market extended its losing streak as the All-Share Index declined by 0.51% to close at 106,904.25 points, bringing the year-to-date return to 3.86%. Market capitalization also dropped by 0.51% to N66.94 trillion, reflecting an equity loss of N344.95 billion by the session's close. Despite the overall market decline, investor sentiment remained weak, as indicated by a negative market breadth, with 17 stocks advancing while 44 declined. Leading the gainers were UHOMREIT (+9.94%), NEM (+8.78%), IKEJAHOTEL (+8.72%), CONHALLPLC (+6.76%), and LIVESTOCK (+4.53%), while ETERNA, TRANSCORP, DANGSUGAR, DEAPCAP, and GUINEAINS topped the list of losers. Sectoral performance was mixed: the Banking, Consumer Goods, and Oil & Gas sectors declined by 1.80%, 0.37%, and 0.36%, respectively, whereas the Insurance, Industrial, and Commodity sectors posted gains of 0.73%, 0.01%, and 0.14%. Trading activity was robust, with total volume and transaction value rising by 28.36% and 21.18%, respectively, while the number of deals fell by 9.74%. A total of 13,967 deals were recorded, with a transaction value of N8.76 billion and a traded volume of 395.47 million units.

## **Money Market**

In the money market, the Nigerian Interbank Offered Rate (NIBOR) declined across all tenors, indicating improved liquidity conditions in the banking system. However, key money market indicators remained stable, with the Open Repo Rate (OPR) holding steady at 26.42% and the Overnight Lending Rate unchanged at 26.83%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) declined across all maturities. Likewise, the secondary market for Nigerian Treasury Bills saw bullish momentum, with increased investor demand driving the average yield down by 11bps to 19.79%..

#### **Bond Market**

The secondary market for FGN bonds showed a positive trend, with the average yield experiencing a decrease of 0.11% to 18.42%.

Bearish sentiment in Nigeria's sovereign Eurobonds market, spanning short-, mid-, and long-term maturities, drove a 2bps increase in the average yield, which closed at 8.97%.

### Foreign Exchange Market

In the foreign exchange market, the Naira appreciated by 0.50% in the official window, closing at \$1,491.67 per dollar. Similarly, the Naira ended the day at \$1,490 per dollar in the parallel market.




