Equities Market Summary

The local stock market extended its downward trend at the close of the trading week as the All-Share Index declined by 0.23% to 106,538.60 points, bringing the year-to-date return to 3.51%. Market capitalization also dropped by 0.23% to N66.72 trillion, reflecting an N151.62 billion loss in equities by session close. Despite the overall market decline, investor sentiment remained positive, as indicated by strong market breadth, with 34 stocks advancing against 18 decliners. Leading the gainers were LIVESTOCK, HONYFLOUR, EUNISELL, MAYBAKER, and TANTALIZER, while IKEJAHOTEL, TRANSCORP, FCMB, CAVERTON, and ABCTRANS topped the list of losers. Sectoral performance was mixed, with the Banking, Insurance, and Consumer Goods sectors posting gains of 0.12%, 1.27%, and 0.42%, respectively. In contrast, the Oil & Gas sector declined by 0.09%, while the Industrial Goods sector remained unchanged. Trading activity was subdued, though total transaction volume and value increased by 7.06% and 4.42%, respectively. The number of deals also rose by 4.05%, with a total of 11,911 transactions recorded, amounting to N9.74 billion in value and 349.19 million units traded.

Money Market

In the money market, the Nigerian Interbank Offered Rate (NIBOR) rose across most tenors, indicating tighter liquidity conditions in the banking system. Meanwhile, key money market indicators moved downward, with the Open Repo Rate (OPR) falling by 1.06% to 27.08% and the Overnight Lending Rate declining by 0.83% to 27.67%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) exhibited mixed movements across all tenors. Meanwhile, the secondary market for Nigerian Treasury Bills saw bearish momentum, driven by heightened investor sell-offs, resulting in a 5-basis-point increase in the average yield to 18.98%.

Bond Market

The secondary market for FGN bonds trended downward, as the average yield edged up by 2 basis point to 18.45%.

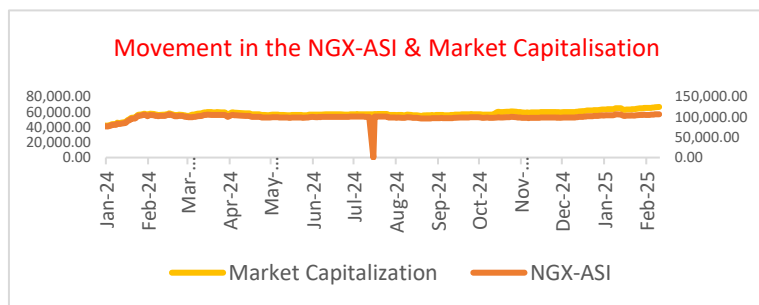
Bearish sentiment in Nigeria's sovereign Eurobonds market, across short-, mid-, and long-term maturities, led to a slight rise in the average yield by 0.28% to close at 9.26%.

Foreign Exchange Market

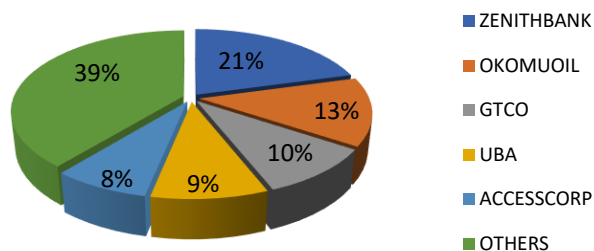
