



Nigerian Stocks Trade Lower on Monday as Investors Lose N7.8Billion... ASI Down 0.15%, NIBOR Falls Signaling Improved Liquidity in the System ...

At the start of the trading week on Monday, the local stock market closed in decline as the All-Share Index dropped by 0.15% to 105,799.17 points, bringing the year-to-date return to 2.79%. Market capitalization also fell by 0.01% to N66.34 trillion, influenced by the listing of 16,666,666,667 ordinary shares of 50 kobo each at N4.50 per share, offered through a private placement by Sterling Financial Holdings Company Plc. This resulted in a N7.8 billion loss in equities by the session's close. The overall market downturn dampened investor sentiment, reflected in weak market breadth, with 18 stocks advancing while 35 declined. Top gainers included ACADEMY, NEIMETH, TANTALIZER, DANGSUGAR, and STANBIC, whereas TANTALIZER, SUNUASSUR, PRESTIGE, SOVRENINS, and REDSTAREX led the list of losers. Sectoral performance was largely negative, as the Banking, Insurance, Consumer Goods, and Oil & Gas sectors posted losses of 0.20%, 1.70%, 0.38%, and 0.19%, respectively, while the Industrial Goods and Commodity sectors remained unchanged at 0%. Trading activity was subdued, with total transaction volume and value declining by 36.38% and 36.25%, respectively. However, the number of deals surged by 27.74%, with 477.51 million units traded across 13,520 transactions, amounting to N7.05 billion in value.

Money Market

In the money market, the Nigerian Interbank Offered Rate (NIBOR) declined across all tenors, signaling improved liquidity in the banking system. Meanwhile, key money market indicators trended upward, with the Open Repo Rate (OPR) rising by 0.02% to 32.42% and the Overnight Lending Rate increasing by 0.03% to 32.83%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) rose across most tenors. Meanwhile, the secondary market for Nigerian Treasury Bills remained bearish, as widespread investor selloffs drove the average yield up by 11 basis points to 19.09%.

Bond Market

The secondary market for FGN bonds trended downward, as the average yield edged up by 13 basis point to settle at 18.47%.

Bearish sentiment in Nigeria's sovereign Eurobonds market, spanning short-, mid-, and long-term maturities, led to a slight increase of 12 basis points in the average yield, closing at 9.54%.

Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 0.66% in the official window, closing at \$1,528.03 per dollar. Similarly, the Naira ended the day at \$1,570 per dollar in the parallel market.






