

Local Bourse Extends Bearish Momentum by 0.02% on Negative Internals, Nitty Rises Across Most Tenors...

The local stock market extended its downward trend this month as the All-Share Index declined by 0.02% to 105,525.26 points, bringing the year-to-date return to 2.52%. Market capitalization also fell by 0.05% to N66.16 trillion following the delisting of Capital One, Med-View Airline, and Goldlink Insurance from the Nigerian Exchange Group, resulting in an N30.44 billion loss in equities by the session's close. The overall market downturn weighed on investor sentiment, leading to weak market breadth—20 stocks advanced, while 32 declined. Top gainers included AFRIPRUD (+9.76%), GUINEAINS (+9.52%), DAARCOMM (+8.33%), MANSARD (+7.87%), and RTBRISCOE (+7.14%). On the flip side, the biggest decliners were LIVESTOCK (-10.00%), PZ (-9.97%), MBENEFIT (-9.35%), UACN (-9.23%), and NSLTECH (-9.09%). Sectoral performance was predominantly negative, with the Banking, Consumer Goods, Oil & Gas, and Industrial Goods sectors posting losses of 0.36%, 0.66%, 0.19%, and 0.02%, respectively. The Insurance sector, however, gained 1.70%, while the Commodities sector remained unchanged at 0%. Trading activity was subdued, as the number of deals, total transaction volume, and value declined by 20.94%, 9.35%, and 27.24%, respectively. A total of 13,667 transactions were recorded, amounting to N8.74 billion in value and 397.12 million units traded.

Money Market

In the money market, the Nigerian Interbank Offered Rate (NIBOR) declined across most tenors, except for the overnight rate, which edged up by 0.02% to 26.86%. Similarly, key money market indicators trended downward, with the Open Repo Rate (OPR) falling by 0.08% to 26.42% and the Overnight Lending Rate dropping by 0.08% to 26.88%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) rose across most tenors, while the secondary market for Nigerian Treasury Bills experienced a bullish trend, driven by strong investor demand that pushed the average yield down by 0.03% to 19.38%.

Bond Market

The secondary market for FGN bonds remained unchanged, keeping the average yield steady at 18.71%.

Bearish sentiment prevailed in Nigeria's sovereign Eurobonds market across short-, mid-, and long-term maturities, driven primarily by investor sell-offs in the March 2029 bond. Consequently, the average yield increased by 0.37% to close at 10.21%.

Foreign Exchange Market

In the foreign exchange market, the Naira appreciated by 0.48% in the official window, closing at ₩1,531.25 per dollar. Similarly, the Naira ended the day at ₩1,535per dollar in the parallel market.
