



Broad-Based Optimism Lifts Market as Investors Wealth Grows by N228 Billion, Naira Depreciates by 0.02% Against the Dollar in the Official Market

The local stock market opened the trading week on a positive note, as the All-Share Index advanced by 0.34% to close at 106,116.18 points. Market capitalization mirrored this performance, rising by 0.34% to ₦66.69 trillion—reflecting an approximate ₦228 billion increase in investors' wealth. Broad-based optimism fueled the session, with most sectors recording gains. The Consumer Goods sector led with a 2.38% rise, followed by Banking (+1.31%), Insurance (+0.32%), and Industrial Goods (+0.31%). In contrast, the Oil & Gas and Commodity sectors declined by 2.87% and 1.72%, respectively. Market breadth was strong, with 47 gainers outpacing 16 decliners. Top gainers included INTBREW, LEGENDNT, CADBURY, FIDSON, and ETERNA, while LIVESTOCK, ARADEL, TRIPPLEG, JOHNSHOLT, and LINKASSURE led the losers' chart. Trading activity remained robust: although market value dropped by 39.97%, the number of deals and volume traded increased by 23.47% and 16.94%, respectively. In total, ₦12.11 billion worth of transactions were recorded in 17,637 deals involving 500.59 million units.

Money Market

In the Nigerian money market, the Nigerian Interbank Offered Rate (NIBOR) showed mixed movements across all tenors. Meanwhile, money market indicators reflected a muted performance, as both the Open Repo Rate and the Overnight Lending Rate remained unchanged at 26.50% and 26.88%, respectively.

The Nigerian Interbank Treasury Bills True Yield (NITTY) declined across all tenors, while the average yield on Treasury bills fell by 0.04 percentage points to 20.79%.

Bond Market

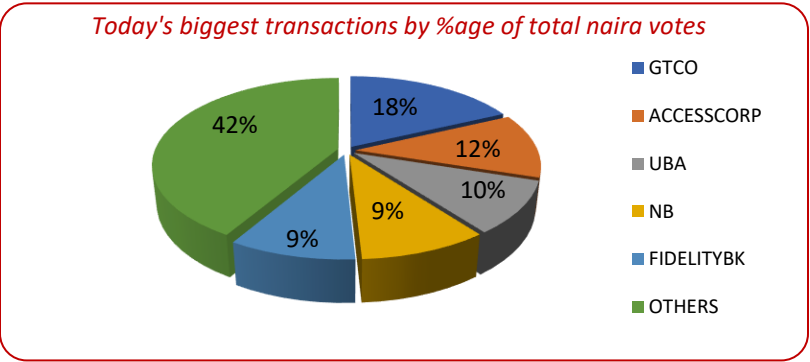
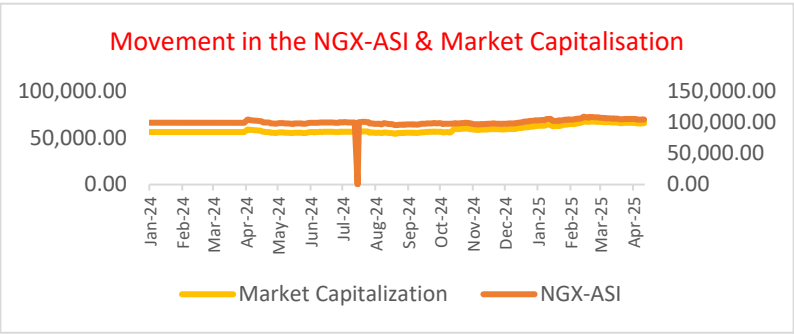
Activity in the secondary market for FGN bonds remained subdued, with the average yield holding steady at 19.02%.

Mixed sentiment prevailed in Nigeria's sovereign Eurobond market, driven by investor behavior across all maturities. Consequently, the average yield remained muted at 10.05%, reflecting the fluctuating bond prices and overall market uncertainty.

Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 0.02% in the official window, closing at ₦1,599.55 per dollar. Similarly, the Naira ended the day at ₦1,610 per dollar in the parallel market.

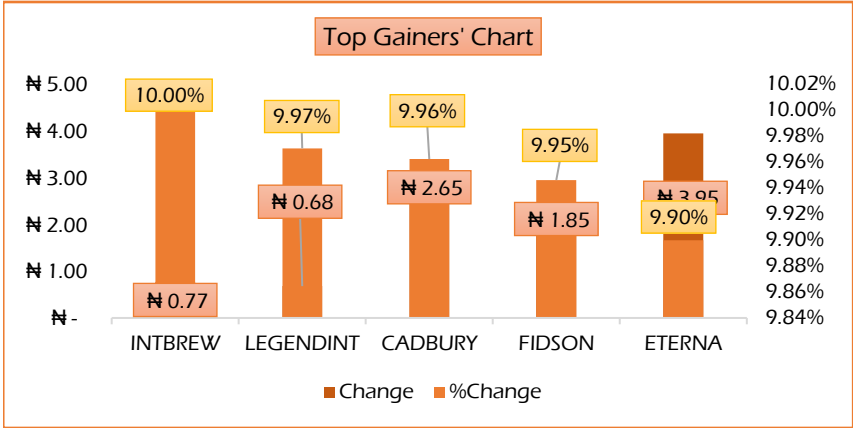

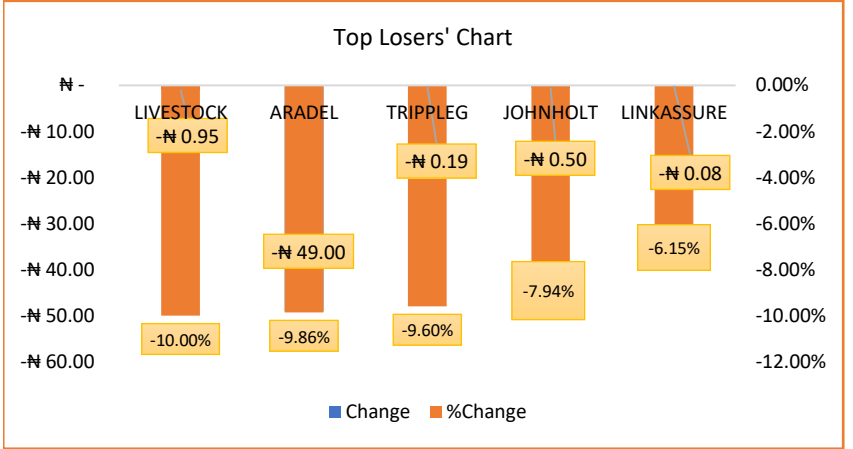

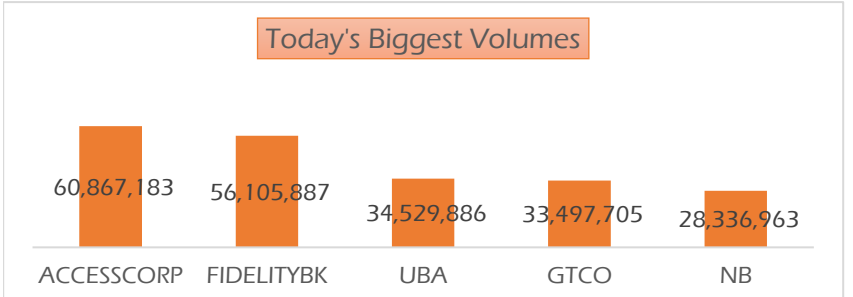
