



Profit-Taking Halts Bullish Streak on NGX as ASI Tanks 0.46%, Naira Depreciates by 0.19% Against the Dollar at the Official Market....

On Friday, the Nigerian stock market reversed its earlier gains from the week, as the All-Share Index (ASI) declined by 0.46% to close at 108,733.40 points. This downturn also led to a 0.46% decrease in market capitalization, bringing it down to ₦68.34 trillion and erasing approximately ₦313 billion from investors' portfolios. The negative performance was reflected across major sectors: Banking (-0.01%), Insurance (-0.22%), Consumer Goods (-0.05%), Oil & Gas (-0.02%), Industrial Goods (-0.18%), and Commodities (-1.94%). Despite the overall decline, market breadth remained positive, with 34 stocks advancing against 32 decliners. Top gainers included ABCTTRANS, STERLINGNG, CHELLARAM, ACADEMY, and REDSTAREX, while TRANSPWE, HMCALL, MEYER, REGALINS, and SUNUASSURE recorded the most significant losses. Trading activity was subdued, with the number of deals, volume, and value declining by 5.87%, 17.12%, and 22.18% respectively. In total, 459.21 million shares worth ₦11.16 billion were exchanged across 15,723 deals.

Money Market

In the Nigerian money market, the Nigerian Interbank Offered Rate (NIBOR) declined across most tenors, except for the overnight rate, which edged up by 0.09% to 26.84%. Meanwhile, key money market indicators remained largely unchanged, with the Open Repo rate holding steady at 26.50% and the Overnight Lending Rate unchanged at 27.00%.

The Nigerian Interbank Treasury Bills True Yield (NITTY) reflected mixed sentiments across all maturities, leading to a marginal 1 basis point decline in the average Treasury bills yield to 20.87%.

Bond Market

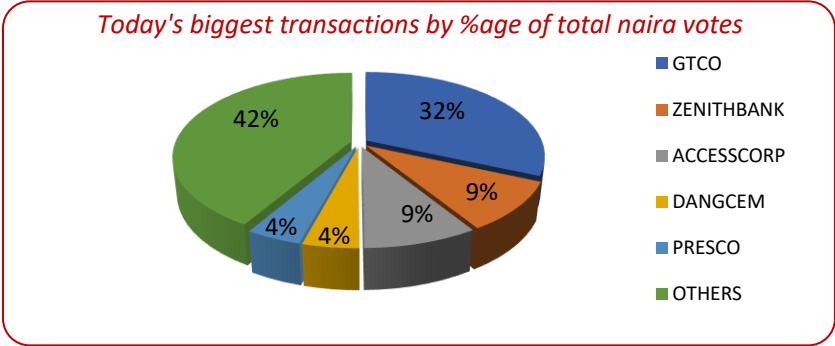
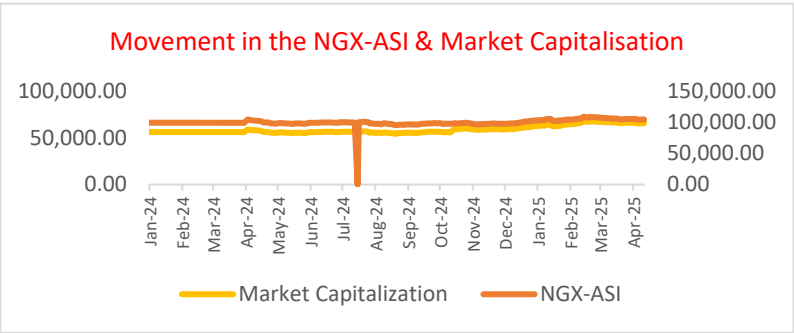
Negative investor sentiment in the secondary market for FGN bonds drove average yields up by 7 basis points to 19.07%.

Investor selloffs had a significant impact on Nigeria's sovereign Eurobond market, fueling bearish sentiment and pushing yields higher across the curve. This led to a slight increase in the average yield, which climbed to 10.36%.

Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 0.19% in the official window, closing at ₦1,609.64 per dollar. Similarly, the Naira ended the day at ₦1,620 per dollar in the parallel market.

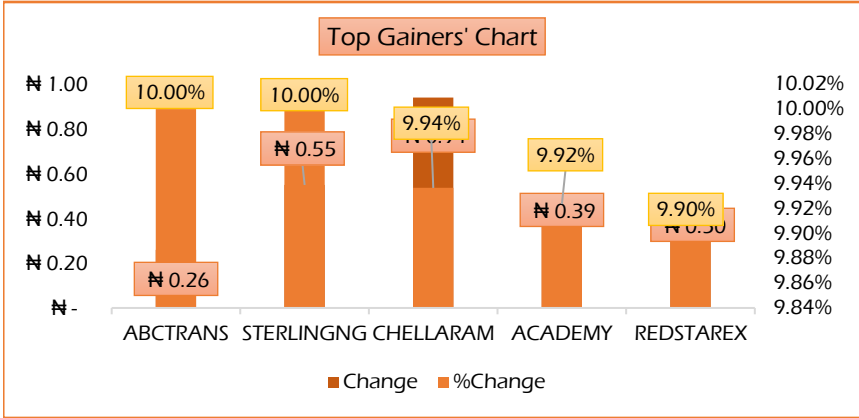

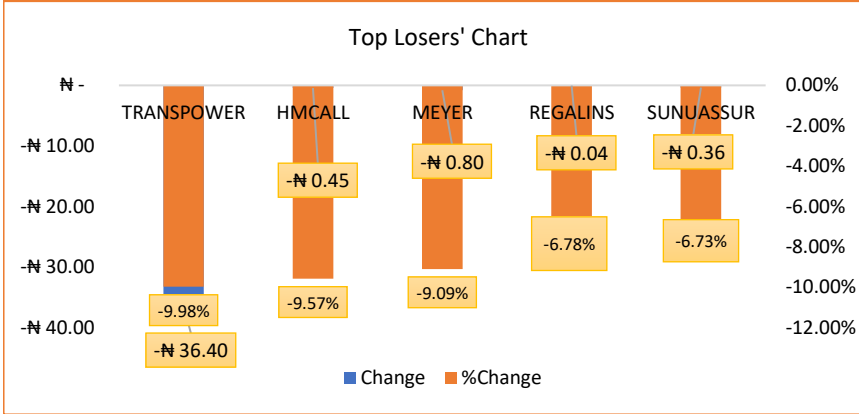

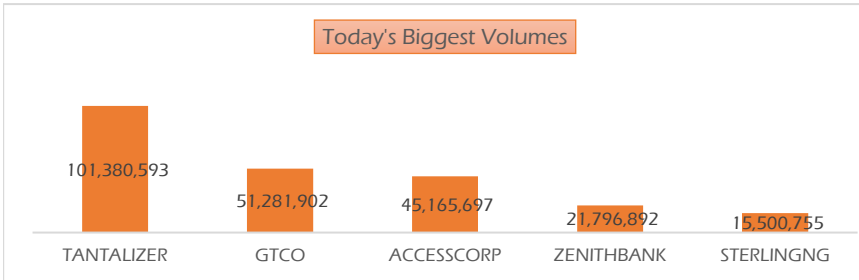
