





Banks Bleed, NGX Slips 0.19% as Investors Hit Risk-Off Panic Button, NIBOR Rises Across all Maturities....

Equities Market Summary

The Nigerian equities market opened the week on a bearish note, as the NGX All-Share Index declined by 0.19% to 115,238.24 points, wiping ₦140.22 billion off market capitalization to close at ₦72.67 trillion. The sell-off was driven by investor reaction to the CBN's directive suspending bank dividend payouts, director bonuses, and new foreign investments. Market breadth was negative, with 21 gainers against 43 decliners. Top gainers included Guineains (+10.00%), Ellahlakes (+9.93%), and LegendInt (+9.87%), while NNFM (-10.00%), Cileasing (-9.68%), and UPL (-9.27%) led the losers. Sectoral performance was broadly weak, with losses in Banking (-1.19%), Insurance (-0.49%), Consumer Goods (-2.73%), Oil/Gas (-2.66%), and Commodities (-4.52%), while Industrial Goods rose 0.42%. Trading activity was muted, as deal count and volume dropped by 6.60% and 32.77%, respectively, though value traded rose by 8.67% to ₦18.98 billion on 618.55 million shares across 18,835 deals.

Money Market

The Nigerian Interbank Offered Rate (NIBOR) increased across all tenors, with the overnight, 3M, 6M, and 12M rates rising by 101bps, 43bps, 57bps, and 74bps, respectively—signaling tighter liquidity in the banking system. Similarly, the money market saw the Open Repo Rate (OPR) and Overnight Lending Rate (OVN) surge by 183bps and 184bps to close at 28.33% and 28.83%, respectively.

The Nigerian Treasury Bills (NITTY) curve declined across all tenors, with yields falling by 16bps, 15bps, 15bps, and 8bps on the 1M, 3M, 6M, and 12M benchmarks respectively. The secondary market remained modestly bullish, as sustained demand for short-dated instruments pushed the average yield down by 2bps to 20.62%.

Bond Market

The FGN bond market remained largely muted, with yields holding steady across maturities; consequently, the average sovereign bond yield stayed flat at 0%, underscoring weak market participation.

The Nigerian sovereign Eurobond market recorded strong bullish sentiment, driven by robust demand for the NOV-25, NOV-27, and SEP-28 maturities, leading to a 25bps decline in the average yield to 9.00%.




