

Equities Market Summary

The Nigerian equities market extended its bullish run on Thursday, as the NGX All-Share Index rose by 0.92% to 117,861.13 points, lifting market capitalization by ₩677 billion to ₦74.36 trillion amid renewed investor optimism. Market breadth was strong, with 43 gainers led by IKEJAHOTEL (+10.00%), BETAGLAS (+9.98%), and LEGENDINT (+9.92%), against 20 losers topped by GUINEAINS (-9.21%) and HMCALL (-5.88%). All major sectors advanced—Banking (+2.99%), Insurance (+1.53%), Consumer Goods (+1.02%), Oil/Gas (+0.24%), and Industrial Goods (+0.16%)—while the Commodities index remained flat. Despite positive sentiment, trading activity was mixed: deal count and value declined by 12.52% and 15.31%, respectively, while volume jumped 39.66% to 893.97 million shares worth ₩22.03 billion across 17,257 deals.

Money Market

NIBOR increased across all tenors, rising by 16bps, 34bps, 24bps, and 32bps for the overnight, 3M, 6M, and 12M rates, respectively—reflecting tighter system liquidity. Meanwhile, money market rates showed mixed movement, as the Open Repo Rate remained unchanged at 26.50%, while the Overnight Rate edged up by 2bps to 26.96%

The Nigerian Treasury Bills (NITTY) curve declined across all tenors—down by 28bps, 50bps, 47bps, and 87bps on the 1M, 3M, 6M, and 12M benchmarks, respectively—amid sustained demand for short-dated instruments, which drove the average yield 15bps lower to 20.42% in the secondary market.

Bond Market

The FGN bond market posted modest gains as stable yields across maturities drove the average sovereign yield down by 19bps to 18.64%.

The Nigerian sovereign Eurobond market recorded mixed sentiment amid active investor participation across the curve, pushing the average yield up by 3bps to 18.93%.

Foreign Exchange Market

At the Nigerian Autonomous Foreign Exchange Market (NAFEM), the naira depreciated by 0.01% to close at ¥1,549 per US dollar, while in the parallel market, it ended at ¥1,580 per dollar. Source: FMDQ, CBN, NGX, S&P Dow Jones, Cowry Research




