



NGX Adds N174.8bn in Value as Bulls Defy Sector Slump, ASI Gains 0.24%, Naira Appreciates by 0.13% Against the Dollar at the Official Market....

Equities Market Summary

The Nigerian equities market extended its bullish run, as the NGX All-Share Index rose by 0.24% to close at 118,138.22 points, pushing the year-to-date return to 14.78%. Market capitalization also gained 0.24%, adding ₹174.8 billion to settle at ₹74.53 trillion. However, market breadth was negative, with 36 decliners against 27 advancers. Top gainers included LEGENDINT (+10.00%), ELLAHLAKES (+9.90%), CHAMPION (+9.63%), GUINEAINS (+8.70%), and ETRANZACT (+7.52%), while SUNUASSUR, NNFM, THOMASWY, LIVESTOCK, and NEM led the laggards. Despite the market's overall strength, sectoral performance was mixed: Insurance (-1.07%), Consumer Goods (-0.16%), Oil & Gas (-0.16%), and Industrial Goods (-0.76%) declined, while the Banking and Commodity sectors advanced by 1.65% and 0.75%, respectively. Trading activity moderated, with volume and value down by 45.52% and 14.99%, respectively, as 487.05 million units worth ₹18.73 billion were traded in 17,421 deals.

Money Market

NIBOR climbed across all tenors, up by 71bps, 30bps, 43bps, and 45bps for the overnight, 3M, 6M, and 12M rates, respectively, indicating tighter system liquidity. Similarly, money market rates trended upward, with the Open Repo Rate rising by 1.67% to 28.17% and the Overnight Rate up 1.96% to 28.92%.

The Nigerian Treasury Bills (NITTY) curve closed mixed, with the 1M and 3M tenors declining by 16bps and 2bps, respectively, while the 6M and 12M tenors advanced by 13bps and 24bps. Consequently, average secondary market yields on treasury bills rose by 13bps to 20.64% amid selling pressure.

Bond Market

The FGN bond market recorded modest gains, with yields declining across most maturities, pushing the average sovereign yield down by 7bps to 18.57%.

The Nigerian Eurobond market closed on a bearish note, reflecting renewed selling interest across the curve. The SEP-28 bond witnessed the most significant pressure, leading to a notable rise in its yield. Overall, the increased selloffs pushed average yields higher by 4 basis points. Consequently, the average yield across Nigerian Eurobonds settled at 8.97%.

Foreign Exchange Market

At the Nigerian Autonomous Foreign Exchange Market (NAFEM), the naira appreciated by 0.13% to close at ₩1,547 per US dollar, while in the parallel market, it ended at ₩1,585 per dollar.




